#### **Item 8 Other Business Matters**

Item 8(2) - At the March 13, 2019 Executive Committee meeting, members approved a draft framework for a proposed amendment to the Alameda County Mayors' Conference Bylaws that would allow a current city councilmember in a city that has a rotating mayor to have the same priority as a mayor elected from a general election for reappointment to a regional board provided the following criteria are met:
