Alameda County Mayors' Conference

Presentation Topic

Director Fremier will provide an overview of the Metropolitan Transportation Commission and the Association of Bay Area Governments; in his presentation, the director will discuss the genesis of both agencies, the merger of the two agencies, who's on the respective boards and the services they provide to the nine-county Bay Area.

Guest Speaker:

Andrew B. Fremier, Executive Director, Metropolitan Transportation Commission

Andrew Fremier is the executive director of the Metropolitan Transportation Commission (MTC) and the Association of Bay Area Governments (ABAG), overseeing a consolidated staff of some 380 who support both the transportation planning, funding and coordinating agency for the San Francisco Bay Area and the council of governments for the region's nine counties and 101 cities and towns. Among many other responsibilities, MTC and ABAG jointly develop and update the Bay Area's long-range transportation, housing and land-use plan, which guides the agencies' policy and investment decisions. The current plan, known as Plan Bay Area 2050, was adopted in 2021 and identifies 35 strategies to make the region better connected, more affordable, healthier and more economically vibrant.

Before his 2023 selection by the Commission to serve as executive director for MTC and ABAG, Mr. Fremier had worked since 2005 as a deputy executive director. Prior to joining MTC, he had a 20-year career at the California Department of Transportation, during which he led the Toll Bridge and Highway construction program, guided development of the successful Toll Bridge Seismic Retrofit Program and served as Chief Deputy District Director for Caltrans District 4.

Mr. Fremier is a licensed engineer in California and the current president of the International Bridge, Tunnel and Turnpike Association. He holds a Bachelor's degree in civil engineering from California Polytechnic State University, San Luis Obispo.

President Jesse Arreguin called the meeting to order on June 14, 2023, at 6:30 p.m. at the Residence Inn Berkeley at 2121 Center Street, Berkeley, California.

2. Approval of the May 10, 2023, Meeting Minutes

President Arreguin recognized Mathew Woodruff, Chief Executive Officer of the Alameda County Alliance for Health. Mathew Woodruff introduced himself and welcomed the opportunity to work collaboratively with cities.

Henry Symons, BART Community Relations Representative, provided information on pending state transit funding and indicated that its final approval is pending Governor Newsom's approval.

Steven Baiter, Executive Director of East Bay Economic Development Alliance, provided information on upcoming events and projects.

5. Member Reports on Regional Activities and Committees

Mayor Arreguin provided an update on the Association of Bay Area Governments (ABAG), indicating that its General Assembly meeting will be held on June 16, 2023, at 10:00 a.m.

6. Appointments to Regional Boards and Call for Applications

President Arreguin announced that the Nominating Committee made its recommendations on the applications included in its June 14, 2023, meeting agenda and opened the floor for comments/nominations. Seeing no additional nominations, it was moved by Mayor Salinas and seconded by Mayor Ezzy Ashcraft that the Alameda County Mayors Conference and the City Selection Committee accept the Nominating Committee's recommendations for the following appointments:

Mayor John Bauters, City of Emeryville, was appointed to the Alameda County Oversight Board for an indefinite term.

Mayor Melissa Hernandez, City of Dublin, was reappointed as a member of the East Bay Economic Development Alliance, Tri-Valley Representative for a full two-year term through June 2025.

Mayor Hernandez was appointed Vice President of the Alameda County Mayors' Conference for a term ending in May 2024.

The motion was approved unanimously and so ordered.

Mayor Marchand requested a nomination from the floor and moved to nominate Mayor Dutra Vernici as the alternate member of the Association of Bay Area Governments. Mayor Arreguin seconded the motion.

7. League of California Cities Reports, Legislative Updates and Actions

Samantha Caygill, Regional Public Affairs Manager, East Bay Division, League of California Cities (League), provided an update on the state's legislative activities, including current AB 1657, AB 400, AB 1637, AB 37, and SB 329. She also encouraged attendance at the June 29, 2023, Bocci Tournament to be held in Danville and announced that registration is now open for the League's Annual Conference.

8. Other Business Matters

Nina Senn, Commissioner of the Alameda County Commission on the Status of Women, outlined changes to the Resolution of the Alameda County Mayors' Conference Supporting the Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW) that was presented at the February 8, 2023, Alameda County Mayors' Conference and requested adoption by the membership. Nina Senn provided an overview of the Resolution and the edits made. She addressed questions raised by Mayors Hannon, Marchand, and Brown.

It was moved by Mayor Dutra Vernaci and Seconded by Vice Mayor Welsh to adopt Resolution 2023-01 a Resolution of the Alameda County Mayors' Conference Supporting the Convention on the Elimination of all Forms of Discrimination Against Women (CEDAW). The Resolution was approved and so ordered with the following vote:

9. Request for Future Agenda Items and Presenters

Mayor Salinas expressed an interest in having a panel of speakers from local universities present at a future meeting, preferably one hosted by the City of Hayward. He also indicated he would trade his city's hosting date to assure compatibility with the university representative's schedule.

10. Host City Mayors' Report

President Arreguin thanked his staff and the venue for its efforts in hosting the event. He then discussed the development, funding, and operations of Berkeley Way Apartments and Hope Center, developed in cooperation with BRIDGE Housing and the Berkeley Food & Housing Project (now called Insight Housing). The development includes affordable housing for low and very low households, supportive housing apartments, a homeless shelter, transitional beds for homeless veterans, a community kitchen, and services for mental health, substance abuse, job training, and social activities. He introduced Calleene Egan, Chief Insight Housing Executive Officer, who discussed project development and activities.

11. Meeting Presentation

President Arreguin introduced Kerry Abbott, Director of Homeless Care and Coordination for Alameda County, and Amanda Wehrman, Director of Homeless Care and Coordination at Homebase, to discuss the first annual Home Together Plan report and to introduce Homebase. Kerry Abbott outlined the details of the Year One Progress Update, highlighting goals, strategies, key takeaways, progress made to date, and response system inventory by jurisdiction. Amanda Wehrman outlined Homebase's scope of services, funding, and activities to date.

The meeting was adjourned at 8:05 p.m.
