Item 6 – Appointment to Regional Boards and Call for Applications

Item 7(a) - Consideration to approve the Executive Director's 2024 Service Agreement

The Executive Committee will be making a recommendation on a professional services agreement with Steven Bocian to serve as the Alameda County Executive Director for the 2024 calendar year. There are no financial changes to the agreement. The services agreement includes a proposed amendment indicating the Executive Director will work with the City of San Leandro and the Mayors' Conference Treasurer regarding the Conference's financial administration. The proposed language is as follows:

1. (*j*) To work cooperatively with the City of San Leandro and the Conference Treasurer concerning their overall financial administration of the Conference, including utilization of Quickbooks for invoicing, accounts payable, preparation of an annual financial report, and other financial matters.

Item 7(b) – Consideration to approve the Alameda County Mayors' Conference CY 2024 Budget and membership dues schedule

The Executive Committee will be making a recommendation on the CY 2024 budget. The budget includes an adjustment to the membership dues and the dinner fee, the purchase of a subscription to Intuit's Quickbooks Essentials, and an increase to the amount host cities are reimbursed from the Mayors' Conference for hosting monthly business meetings from \$50/person to \$75/person, and a one-time dinner fee offset for 2024 of \$1,150. It also anticipates the regional agencies attending dinner following the monthly business meetings will pay \$75/person. The \$75 reimbursement amount is anticipated to begin around March/April 2024 after implementing invoicing and other related matters.

For the purpose of <u>conducting presenting</u> the <u>audit_annual financial report</u>, the Executive Committee <u>shall_may</u> retain the services of a private certified public accounting firm<u>or have it presented by the Executive Director</u>.

ALAMEDA COUNTY MAYORS' CONFERENCE MINUTES

Meeting of November 8, 2023

The meeting was called to order by Vice President Hernandez on November 8, 2023, at 6:30 p.m. at California State University, East Bay, New University Union building located at 25800 Carlos Bee Blvd, Hayward, California.

1. Roll Call

2. Approval of the October 11, 2023 Meeting Minutes

It was moved by Mayor Bauters and seconded by Mayor Dutra-Vernaci to approve the October 11, 2023, meeting minutes. The motion was approved unanimously.

3. Agenda Amendments

There were no agenda amendments.

4. Public Comments and Other Announcements

BART Board Vice President Mark Foley announced that the state approved additional BART funding.

5. Member Reports on Regional Activities and Committees

Mayor Dutra-Vernaci provided an update on the Metropolitan Transportation Commission, indicating that it is discussing concepts related to a potential new regional transportation funding measure.

Mayor Bauters provided an update on the Bay Area Air Quality Management District, indicating it has adopted a new administrative code and has completed filling many vacant staff positions.

6. Appointments to Regional Boards and Call for Applications No appointments were scheduled for this meeting.

7. Other Business Matters

Steven Bocian, Alameda County Mayors' Conference Executive Director, provided an overview of the Executive Committee's action concerning changes to financial administration and increasing membership dues and the Dinner Fee potentially beginning on January 1, 2024. He indicated the item would be on the December 13, 2023, business meeting agenda for review and approval.

8. Request for Future Agenda Items and Presenters

No recommendations were made for future agenda items or speakers

9. League of California Cities Reports, Legislative Updates and Actions

Samantha Caygill, Regional Public Affairs Manager, East Bay Division, League of California Cities (League), provided an update on pending state legislation and League activities and discussed the governor's bill signing activity. She also discussed the proposed Taxpayer Protection and Government Accountability Act sponsored by the California Business Roundtable on the November 2024 ballot. She advised cities to remain engaged in this initiative and indicated it is currently facing a legal challenge.

10. Host City Mayors' Report

Mayor Salinas thanked all involved in coordinating the event, introduced city staff and councilmembers, and made a presentation highlighting the relationship and impacts of public schools in Hayward and Alameda County. He stressed the importance of the educational sector's contributions to the region's economy and the importance of maintaining close relationships between cities and the education sector.

11. Meeting Presentation

Mayor Salinas introduced California State University, East Bay, President Cathy Sandeen, Chabot College President Hanal Cooks, and Hayward Unified School District Superintendent Jason Reimann. Hayward proclaimed an education city. The speakers provided a summary of their pathway to their current university. Mayor Salinas asked the speakers specific questions regarding current educational issues and perspectives and used software to interact with the audience. The panel stressed a shared vision for the betterment of students, residents, and businesses. Mayor Salinas discussed the scope and benefits of being an educational city.

The meeting was adjourned at 8:35 p.m.
